Since 1992, Family Promise of the Main Line (FPML) has been providing a pathway to hope and stability for our most vulnerable neighbors - those who are literally homeless. We are grateful to our philanthropic partners who have provided critical support during these especially challenging years of the pandemic and our nation's recovery.

The economic and public health impact of the pandemic, and today's high inflation and worsening affordable housing crisis, continues to threaten the stability of economically marginalized families in Montgomery County. We continued to work towards maintaining 100% capacity levels of our Emergency Shelter program once we resumed that level of operation in early 2021, including re-engaging our congregational partners and working with them to resume our rotational shelter model. We also ambitiously pursued funding to expand diversion and prevention services, strengthening the county's safety net to keep families stably housed and out of the county's woefully overburdened emergency shelter system. Reaching 100% capacity of our Emergency Shelter was critical, helping us house 13 families in Emergency Shelter in FY2022, compared to 9 in FY2021. In FY2023 we housed 16 families, including the siblings pictured above, returning us to our pre-pandemic levels.

services, illuminated the incredible need in our community for ongoing support to families who are recently housed after experiencing homelessness, as well as for families facing imminent eviction. As a critical partner of Montgomery County's social safety net, FPML ambitiously pursued funding opportunities throughout FY2022 and FY2023 to further expand our comprehensive prevention and diversion services. These services help families avoid a housing crisis and remain stably housed, including on-going case management, cash assistance, and negotiating with landlords and utility companies, among other critical supports.

A total of 53 families received prevention and diversion services; 37 families received rental assistance to avoid imminent eviction. Sixteen families were recent graduates of our emergency shelter and enrolled in our Graduate Self-Sufficiency program (diversion services). These recently housed families received monthly in-person case management sessions as well as weekly or bi-weekly check-ins. With our assistance, families increased their budgeting skills and credit repair, gained access to local mental health services, WIC, children's educational services, and other community supports, and got help understanding their child's Individualized Education Plan (IEP) to better advocate for their children's needs. Additionally, our Program Manager successfully advocated for eight of our families to receive a section 8 housing certificate and assisted another 2 families with utilizing a section 8 certificate. To date, all enrolled households remain stably housed, exceeding our expectations.

FPML also provides critical information and referral services to community members seeking help with myriad issues that put them at risk of a housing

crisis - rental assistance, utility assistance, food assistance, benefits assistance, transportation assistance, childcare assistance, as well as information about our emergency shelter services. In FY2022 we answered 650 calls. As the affordable housing crisis worsens in Montgomery County, and living expenses become more costly, calls to our office have skyrocketed. Staff responded to over 1,000 calls in FY2023, about 3-5 calls per day.

We are grateful to all of our partners and supporters who are helping our most vulnerable neighbors regain and maintain their housing, and reach economic self-sufficiency.
