1992 a group of concerned citizens launched IHN-ML by sheltering its first family, a mother and two daughters, through a network of local congregations committed to serving neighbors experiencing homelessness. Built from the nationally proven Interfaith Hospitality Network program model (now called Family Promise), IHN-ML continues to empower Montgomery County, PA families through community-based partnerships that include over 600 volunteers and 24 local congregations who provide emergency shelter.

IHN-ML continues its mission to enable volunteers from local congregations and the broader community to provide compassion and temporary shelter for homeless families. IHN-ML's programs and services connect the families to community resources, empowering them to achieve and maintain affordable housing. IHN-ML continues to serve the most vulnerable families of our community with a goal of increasing their long term economic and housing stability. Thus helping family homelessness to be rare, brief and nonrecurring.

IHN-ML is a member organization of the Montgomery County Your Way Home collaborative. This collective impact model coordinates care through a central referral system and shared outcome measures. IHN-ML's model is unique, in that we utilize the collective effort of volunteers and church congregations for the evening sheltering of the families. We are also able to accommodate families of various compositions, such as multi-generational households, households with teenage males and or adult children, single parent females or males. IHN-ML households are 100% low income according to HUD definition. 90% are extremely low income at the time of intake.

Homelessness is traumatic for the entire family; it is particularly traumatic for children who often bear the brunt of precarious housing and the fears of an unpredictable future. Children in homeless families face potentially devastating developmental, social, and academic consequences. IHN-ML's overall goal is to end homelessness for each participant family – we aim to keep families intact and reduce the harms on children so they can thrive. Our unique, trauma-informed approach combines the stability of emergency shelter and the benefits of intensive case management services to empower 14-16 families annually (approximately 50 individuals) to re-gain housing within 90 days and ultimately reach economic self-sufficiency by continuing to access a large network of stabilizing community supports as needed.

Emergency Shelter: Ten host congregations provide private sleeping accommodations for a week at a time, on a rotating schedule. With volunteer support from 14 additional congregations, a daily dinner is served alongside compassionate, warm companionship. On any given week 40 to 60 volunteers provide critical resources and time for our programming. In FY18-19 over 11,000 volunteer's hours were counted.

Mornings and evenings, our Transportation Manager drives families in our agency van to and from our host congregations and Day Center, located in the heart of Norristown and centrally located to numerous social

services and public transportation. The Day Center serves as “home base” and includes access to laundry facilities and showers, a locked storage area for personal belongings, a kitchen, a computer with

Internet access for parents to search for housing and employment and children to complete homework, and a backyard play space.

Intensive Case Management: All adults receive on-going, person-centered case management at the Day Center. Central to case management is each family’s Housing Stability Plan, which employs Housing First best practices, and includes supports necessary to achieving and maintaining housing, such as employment, child care, transportation, and health care. A team approach is utilized, consisting of close collaboration between the participant, our program manager, Your Way Home’s Housing Resource Center staff, and case managers from other stabilizing community resources. The goal is to improve awareness of and connectivity to community supports so families can recognize the resources they have and can confidently access them well beyond their stay in emergency shelter – this work greatly improves their economic self-sufficiency and long-term stability. Further, families take goal-directed steps while in residence to increase their income; when they exit, they receive short term financial support to bridge potential wage gaps.

Organizational accomplishments:

In FY 2018-2019, our comprehensive programming served 15 families, consisting of 45 individuals (18 adults, 25 children). Of these 15 families, 11 households graduated and 4 remain in the program. Of our 11 graduating families; 7 were rapidly re-housed to affordable housing and remain in their apartments to date, 1 household increased daily living skills to return to family members and then entered rehab, 3 households choose to exited to other emergency shelter. Additionally, 61% of the families that left the program increased their income while 39% maintained their income. 100% of the families that left the program were connected to two or more community resources and benefit assistance that will support long-term stability and economic self-sufficiency, including WIC, SNAP, food pantries, health services, and employment services, among others. Of the 4 households that remain in the program 75% have increased income while 25% have maintained their income. 100% households remaining in program were connected and now receiving 2 or more community resources and benefits. 100% remaining households have been connected to next step housing resources and have a housing stability plan in place.

The average length of stay in IHN-ML program was 78 days. All 15 households are headed by women and 3 of those households were youth age (18-25). 7 heads of households reported Mental Health diagnosis, 7 heads of household chronic health issues, 2 households reported one member having physical disability, 4 heads of household domestic violence and 1 actively fleeing domestic violence, 2 heads of household reported drug and alcohol issues past and present.

During FY 2018-2019 IHN-ML developed a board-driven strategic plan and employed a highly skilled Program Manager in August 2018. Our strategic plan will guide growth efforts over the next 3 years to deepen our impact in the community. Specific goals of the plan include: 1) Implement a static shelter model; 2) Advance evaluation methods; 3) Launch new services to deepen our impact, including housing diversion counseling and after care services; 4) Improve communication with partnering congregations and the community at large; 5) Increase fundraising efforts; 6) Improve organizational capacity through leadership development; and 7) Embody equity and inclusion at all levels of the organization.

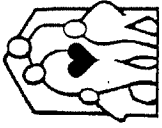
